Sheppard as Secretary to the Board/Executive Director; Commissioner Onderdonk as

representative to the Glencoe Plan Commission; and Lisa M. Sheppard and Jennifer L. K. Runkel as Freedom of Information Officers. Commissioner Lerman seconded the motion. Roll call vote taken:

Board Committee Appointments: President Gaines appointed Commissioners Brooks, Gaines, Lerman, Onderdonk, and Palatnik to the Finance Committee of the Whole with Treasurer Brooks as Chair. President Gaines appointed Commissioners Lerman, Brooks, and Gaines to the Special Projects and Facilities Committee with Commissioner Lerman as Chair. President Gaines appointed Commissioners Palatnik, Brooks, and Gaines to the Personnel and Policy Committee with Commissioner Palatnik as Chair.

Committee meetings will be held on the first Tuesdays monthly at 7:00 p.m.

<u>Financial Report</u>: Director Mensinger stated we are two months into the fiscal year. A Recreation Department decrease in revenue is due to Glencoe Junior Kindergarten canceling their extension program due to the District 35 full day kindergarten program, lower camp revenue, and two payrolls in May.

Staff Reports: Staff shared additional information not included in their Board Reports. Director Leiner stated that weather has created wet condition that have delayed mowing of parks. He also indicated that Veterans Park plaza landscape design has been updated. The first draft of the roof bid from ACG will be coming this week. The last property inspection was completed this week, with the final draft coming in June. Glencoe's Memorial Day event on May 30 is run by the Village with support given by the Park District.

Director Mensinger shared that we received the first draft of the Audit report for the Finance Committee of the Whole meeting.

Director Lushniak added that the Recreation Team has been busy transferring kindergarten classes to evening and weekends and completing brochure information for Manager Maassen. The District passed the DCFS audit with flying colors. The Beach opens next weekend. The biggest impact to loss of beach due to rising water levels is on the boating beach and Facility Manager Bobby Collins worked on relocating boats. Due to work on Old Green Bay Road, the camp drop off location this summer will be at Park 7n.

Manager Maassen stated that our commercial ended well with 70% viewership. Marketing and Recreation Interns are starting Monday. Beach signage updating is underway with regard to content and location of highest impact. The weekly Beach Pass push started last week on Wednesdays. The summer sampler goes out tomorrow. Rental equipment is now in a more visible location on the swimming beach.

Executive Director Report: Executive Director Sheppard met with Sandra Bahrmasel who was part of the original group who fundraised for Liza's Gazebo. She loved the final designs and was appreciative that it will remain Liza's Gazebo with the same look. She fought for brick pavers the first time around and was able to find two anonymous donations totaling \$10,000. With the donation and Board approval, they have been added to the design. The dedication is set for Sunday, September 11, 2016 at 2:00 p.m. All Staff training is scheduled for seasonal and programming staff on Wednesday, June 1 at 6:30 p.m. Commissioners are welcome. Unplug 'N Play is theme this summer #UnplugGlencoe. The Fourth of July Talent Show has been moved to Wyman Green. Staff is looking for food trucks for the Fourth of July event. The Special Projects and Facilities meeting will be held on Tuesday, June 7 at 7:00 p.m. The Berlin Park Groundbreaking Ceremony is on Monday, June 6 at 6:45 p.m. Our IPRA Park Pursuit team won first place. The Director's Message included in the report will be in this month's Glencoe Quarterly.

The Safety Committee has no major issues to report. The committee is currently discussing summer safety, reviewing staff who should serve on the committee, and reviewing safety manuals. Part-time staff will receive onsite training and manual training. Playground inspections are documented monthly.

Matters from the Public: There were no matters from the public.

Other Business: Commissioner Onderdonk shared that there will be Downtown Tuneup Workshops on Saturday, May 21 from 11:00 a.m.-1:00 p.m. and Wednesday, May 25 from 6:00-8:00 p.m. to present commission ideas.

Adjourn: Commissioner Lerman moved to adjourn the meeting at 8:19 p.m. Commissioner Palatnik seconded the motion, which passed by unanimous voice vote.
