General Camper Guidelines

- Campers should wear gym shoes to camp. If the child prefers sandals, they must have a closed heel. No flip flops, please.
- Campers cannot leave camp without staff supervision.
- All campers must wear camp T-shirts on field trip days.
- All campers must provide their own sunscreen and bug spray.
- If your child must receive medication while under the care of the Park District, you must contact the program manager in charge of your child's camp and complete and submit all appropriate paperwork by no later than June 10. Each required form must be completed for each camp your child is registered for. Required forms may include all or any of the following: (1) Waiver and Release of All Claims for Use of Inhaler or Auto-Injector; (2) Permission to Dispense Medication/Waiver and Release of All Claims; (3) Medication Dispensing Information; and (4) Emergency Health Care Plan.

Participant Conduct Policy

In keeping with our program goals, we encourage fun for all our participants. However, certain rules are necessary to ensure everyone's safety and enjoyment.

Participants are expected to exhibit appropriate behavior at all times as outlined below. Additional rules may be developed for specific camps as deemed necessary by staff.

Participants shall:

- Show respect to all staff and participants;
- Refrain from using foul or obscene language;
- Refrain from causing bodily harm to other participants or staff;
- Show respect for equipment, supplies and facilities;
- Refrain from disparaging remarks, including comments against an individual's race, ethnic background, religion, physical appearance or disabling condition.

The Glencoe Park District reserves the right to expel or deny participation to any person in any program, event or facility whose behavior interferes or disrupts the quality of those offerings or the staff or other participants engaging in them.

A child's parents or guardians shall be notified of the first incident; the second incident shall require the presence of a parent at a meeting with the instructor and a Park District Administrator/Program Manager; a third incident may result in an expulsion of the child from the program, event or facility.

Discipline

The Glencoe Park District staff will use a firm, positive approach regarding discipline. The purpose of discipline is to help a child develop self control and learn to assume responsibility for his/her own actions. We use positive statements and reinforcement to redirect negative behavior.

The Glencoe Park District reserves the right to dismiss a participant whose behavior endangers the safety of him/herself or others. Each situation will be evaluated on its own merit. The safety and enjoyment of all campers is our main concern.
