### PERMISSION TO RELEASE PARTICIPANT WITHOUT SUPERVISION

For the safety and welfare of the children under the supervision of the staff at the Glencoe Park District, a child who leaves the premises of a Glencoe District Program must be released to an adult whom the parent or guardian has so indicated on the Carpool Authorization Form. An exception can be made with written notice from a parent or guardian.

I do hereby fully release and forever discharge the Park/School District from any and all claims for injuries, damages, or loss that I or my child/ward which may accrue to me or him/her arising out of, connected with, or in any way associated with release of my child without supervision.
