GLENCOE PARK DISTRICT ORDINANCE No. 836

AN ORDINANCE AUTHORIZING A DONATION AND NAMING RIGHTS AGREEMENT WITH ANDREW T. BERLIN

WHEREAS, the Glencoe Park District ("Park District") is a park district organized under the Illinois Park District Code, 70 ILCS 1205-1 et seq.; and

WHEREAS, the Park District is the owner of certain real property currently known as Central Park; and

WHEREAS, the Park District's Board of Park Commissioners ("Board") desires to renovate and reconstruct Central Park, including the renovation and reconstruction of a baseball field and other appurtenances; and

WHEREAS, Andrew T. Berlin ("Donor") has expressed to the Board a desire to donate to the Park District \$1,000,000 to be used for to pay for the renovation and reconstruction project at Central Park; and

WHEREAS, Section 8(b) of the Illinois Park District Code authorizes park district boards to pass all necessary ordinances, rules and regulations for the proper management and conduct of the business of the board and district; and

WHEREAS, the Board has established policies governing donations and the naming/renaming of parks and facilities; and

WHEREAS, under the provisions of Section 8(a) of the Illinois Park District Code, the Board has authority to contract in furtherance of any of its corporate purposes; and

WHEREAS, the Board and Donor have negotiated a Donation and Naming Rights Agreement ("Agreement"), attached hereto as Exhibit A, under which, in exchange for Donor's donation, the Park District shall use "Melvin Berlin Park" as the name of the park and "Melvin Berlin Field" as the name of the Baseball Field; and

WHEREAS, the Board hereby finds and determines it to be in the best interest of the Park District and its residents to enter into the Agreement;

NOW, THEREFORE, BE IT ORDAINED by the Board of Park Commissioner of the Glencoe Park District, as follows:

SECTION 1. The recitals set forth above are incorporated into this Ordinance as the material findings of the Board of Park Commissioners.

SECTION 2. The Board President is hereby authorized and directed to execute the Donation and Naming Rights Agreement with Andrew T. Berlin.

SECTION 3. To the extent that the Donation and Naming Rights Agreement and/or this Ordinance conflicts with any provision in the Park District's Gifts and Donations or Naming (Renaming) Parks and Facilities policies, or any other Glencoe Park District policy or ordinance, the conflicting provisions in those policies and/or ordinances are waived and the Agreement and this Ordinance shall govern.
